SUBJECT: Grant of provisional Multi System Operator (MSO) registration to **M/s Citi Online Services Ltd.** under Rule 11E of the Cable Television Network Rules, 1994 for operating in the areas notified under section 4A of the Cable Television Networks (Regulation) Act, 1995- regarding.

Sir,

With reference to the application dated 29.10.2012 for issuing certificate of registration to operate as a Multi System Operator (MSO) in the Digital Addressable System (DAS), the approval of the Registering Authority is hereby conveyed for grant of the said registration to M/s Citi Online Services Ltd, 701, Aditya Trade Center, Ameerpet, Hyderabad- 500038 to operate as MSO in **Phase II** cities viz. Hyderabad, Vishakhapatnam, Bangalore & Mysore notified in the notification of Government of India, Ministry of Information and Broadcasting S.O. No. 2534(E), dated 11th November 2011, **on purely provisional basis** under Rule 11E of the Cable Television Networks Rules, 1994 from the date of issue of this letter subject to security clearance to be received from Ministry of Home Affairs.

2. The grant of the said provisional registration for operating as an MSO shall not confer any right on the company to claim continuance of the said registration in case the security clearance is denied by Ministry of Home Affairs. In the event MHA denies the security clearance, the MSO shall be liable to shut down its operations forthwith without any protest or demur and the company shall have no claim whatsoever against the Government for any investment made in lieu of obtaining the said provisional registration. The company will be solely responsible to bear the loss incurred on this account.

3. This provisional registration is further subject to adherence and compliance of the following terms and conditions:

- (i) **The MSO shall comply with all the provisions of the Cable Television Networks (Regulation) Act, 1995 and the Rules made there under, as amended.**
- (ii) **The MSO shall abide by the rules / regulations/ orders / directions / guidelines etc. issued by the regulatory authority or by this Ministry from time to time.**

- (iii) The MSO shall have the capacity to carry minimum number of Television Channels specified by the Authority.
- (iv) The MSO shall not carry programming service provided on the channel generated at the level of such Multi-System Operator which is in violation of the Programme Code specified in Rule 6 and the Advertising Code specified in Rule 7 of the Cable Television Networks Rules, 1994.
- (v) The registration granted above is not transferable.
- (vi) The MSO shall comply with Foreign Investment Guidelines and conditions thereon for Cable TV Sector issued by the Central Government from time to time.
- (vii) The MSO shall have an independent digital head-end of his own.

4. The MSO shall set up and operationalise the digital head-end with necessary Conditional Assess System (CAS) and Digital Addressable System (DAS) by the date notified for implementation of DAS Phase-II. In the event the MSO fails to operationalise digital addressable system in the Cable TV Network in any or all the cities for which this Provisional Registration is granted by the notified date, this provisional registration will no longer be valid and shall automatically lapse for that / those city(ies). In such case, the MSO shall have no claim whatsoever for investment made pursuant to the grant of this Provisional Registration. The MSO shall be solely liable to bear the loss, if any, on this account.


5. The MSO shall display the above terms and conditions at a conspicuous place in the office premises of the business as well as in the office premises of the affiliated cable operators.

6. The MSO shall ensure its continued eligibility as applicable throughout the period of the registration and adhere to all the terms and conditions failing which this registration is liable to be terminated/cancelled forthwith without giving any notice.


